

Minutes

The Respiratory Care Advisory Committee of the Board of Medical Licensure and Supervision met on February 28, 2023. This amended meeting was held consistent with the Oklahoma Open Meeting Act. Advance notice of this meeting was transmitted to the Oklahoma Secretary of State on January 27, 2023, and posted on the Board's website on February 1, 2023, at 12:25 PM pursuant to 25 O.S. § 311(A)(9).

Mr. Grantz, having determined a quorum, called the meeting to order at 11:30 a.m. Barbara Smith called roll to establish the quorum on the record.

Following review, Dr. Fixley moved to approve the minutes of December 1, 2022, as written. Ms. Beard seconded the motion and the vote was unanimous in the affirmative.

Next, the Committee considered nominations for Committee Chair and Vice-Chair pursuant to Okla. Admin. Code 435:45-1-4(a)(1). Following discussion, Dr. Fixley moved to nominate Mr. Grantz to serve another term as Committee Chair. Ms. Tenney seconded the motion, Mr. Grantz accepted the nomination, and the vote was unanimous in the affirmative.

Next, Ms. Beard moved to nominate Ms. Crouch to serve another term as Committee Co-Chair. Dr. Fixley seconded the motion and the vote was unanimous in the affirmative. Ms. Crouch was not present at the meeting and Barbara Smith advised she would contact Ms. Crouch regarding accepting the nomination.

THOMAS COLVIN appeared virtually in support of his application for Respiratory Care Practitioner licensure. His application is incomplete. Mr. Colvin has never held an Oklahoma license and has not practiced in the previous 12 months. He last practiced in March of 2021 and he is currently licensed in Colorado. He currently lives in Mangum, Oklahoma, and he

is hopeful to practice there. Mr. Colvin stated that he is current on CEUs required for his NBRC. Dr. Fixley moved to recommend approval of this application upon completion of the file. Mr. Moss seconded the motion and the vote was unanimous in the affirmative.

AMANDA MARTIN appeared in person in support of her application for Respiratory Care Practitioner licensure. Her application is complete. She last practiced in June of 2014. Her Oklahoma license expired August of 2014 and her NBRC expired in 2018. Ms. Martin advised she was home with her young children during the time her license was inactive. She is currently working in DME sales with CPAPs and BIPAPs. She has a job opportunity with Mercy as a patient rehab assessment specialist. According to Medicare guidelines, a healthcare license is required for this position. She is not current on CEUs. Following discussion, Dr. Fixley moved to refer this matter to the Oklahoma Medical Board. Ms. Beard seconded the motion and the vote was unanimous in the affirmative. No personal appearance is required before the Medical Board; however, if Ms. Martin would like to appear in support of her application she may do so.

PETER WEBER appeared personally in support of his application for Respiratory Care Practitioner licensure. He has never held an Oklahoma license and he last practiced in June of 2013. His NBRC is current and he is currently licensed in Wisconsin and Michigan. He stayed involved in respiratory care businesses when his license was lapsed, but he did not provide bedside care. He is also in good standing with the AARC. Following discussion, Dr. Fixley moved to refer this matter, upon completion of the application, to the Oklahoma Medical Board. Mr. Moss seconded the motion and the vote was unanimous in the affirmative. No personal appearance is required before the Medical Board; however, if Mr. Weber would like to appear in support of his application he may do so.

Next, the Committee reviewed applications for licensure. Dr. Fixley moved to recommend approval of the incomplete application(s) for Provisional Respiratory Care Practitioner licensure as identified on the page(s) attached as **Attachment #1** hereto pending completion of the file(s). Mr. Moss seconded the motion and the vote was unanimous in the affirmative.

Dr. Fixley moved to recommend approval of the complete application(s) for Provisional Respiratory Care Practitioner licensure as identified on the page(s) attached as **Attachment #1** hereto. Mr. Moss seconded the motion and the vote was unanimous in the affirmative.

Ms. Tenney seconded the motion and the vote was unanimous in the affirmative.

Ms. Beard moved to recommend approval of the complete application(s) for Respiratory Care Practitioner licensure as identified on the page(s) attached as **Attachment #1** hereto. Dr. Fixley seconded the motion and the vote was unanimous in the affirmative.
