Minutes

The Occupational Therapy Advisory Committee of the Board of Medical Licensure and Supervision met on January 15, 2009 in accordance with the Open Meeting Act. The meeting was held at the office of the Board, 5104 North Francis, Suite C, Oklahoma City, Oklahoma. Members present were:

The meeting was called to order at 9:00 a.m. The first item of business was approval of the minutes from the October 9, 2008 Committee meeting. The Committee noted for the record that, although meeting dates for 2009 were selected in the October meeting, subsequently the July meeting date had been changed to June 18th. Ms. Castleberry moved to approve the minutes. Ms. Schaffner seconded the motion and the vote was unanimous in the affirmative.
