Noting that a quorum was present, Mr. Wersal called the meeting to order at 11:40 a.m.

The Committee reviewed the minutes from the October 28, 2010 Committee meeting. Dr. Britt moved to approve the minutes as written. Ms. Hart seconded the motion and the vote was unanimous in the affirmative.

At the request of the applicants, Ms. Hart moved to table the applications of **Holly Tina Myers** and **Ayisha Ruth Wilcots**. Mr. Porterfield seconded the motion and the vote was unanimous in the affirmative.

Peggy Diane Satterly – appeared in support of her re-entry application for Respiratory Care Practitioner licensure after surrender. Ms. Scott, AAG presented the application. Ms. Satterly surrendered her license in lieu of prosecution after being disciplined by several hospitals and lying on her renewal applications and application for a license in Florida. The Committee reviewed a psychiatric evaluation from Dr. Mohammed and questioned Ms. Satterly on reasons for the five hospital terminations. Ms. Hart moved to enter into Executive Session. Ms. Smith seconded the motion. All voted aye. Dr. Britt moved to enter into open session. Ms. Hart seconded the motion. All voted aye. Ms. Hart moved to recommend denial of the application for reinstatement based on the multiple hospital dismissals relating to patient care. Ms. Smith seconded the motion and the vote was

unanimous in the affirmative.

Joshua Ryan Copeland – Applicant, Respiratory Care Practitioner licensure, appeared in person at the request of the Board Secretary to discuss his arrest and one year probation for threatening bodily harm to someone in a chat room. After questioning the applicant, Ms. Hart moved to recommend approval. Dr. Britt seconded the motion and the vote was unanimous in the affirmative.

Roger Thomas Peak – Applicant, Respiratory Care Practitioner licensure. Ms. Scott presented his application and Agreement for Licensure. Mr. Peak was arrested in 2010 for a DUI. He had met with the Board Secretary who recommended an Agreement. Applicant had not signed the Agreement and was notified to appear at the Committee meeting. Dr. Britt moved to recommend tabling the application until he appears before the Committee. Ms. Hart seconded the motion and the vote was unanimous in the affirmative.

Jacqueline Suzanne Taylor – Applicant, Respiratory Care Practitioner licensure appeared before the Committee. Ms. Scott presented her application. The Board Secretary had recommended she meet with the Committee to discuss a 2006 incident in Missouri where she was terminated for practicing beyond the scope of her license and disciplined by the Missouri Board. After discussion Mr. Porterfield moved to recommend approval. Dr. Britt seconded the motion and the vote was unanimous in the affirmative.

Karen Sue Waters – Applicant, Respiratory Care Practitioner licensure appeared in support of her application. She had not practiced respiratory care since 2008; however, had kept up her CEUs and had a current license in California. She was eligible to take the RRT exam. Ms. Hart moved to recommend approval. Ms. Smith seconded the motion and the vote was unanimous in the affirmative.

Carol Smith reported on the NBRC annual meeting. The topic of expiring credentials was discussed. Some States are revoking licenses where the credentials have expired. Oklahoma does not have a provision for that and would most likely require a law change. Another issue discussed at the NBRC meeting was temporary licenses, which are all but gone. Oklahoma still gives temporaries. Carol Smith asked if staff could get some data to see if Oklahoma was behind on these issues. There were also discussions on laws regarding sleep medicine and respiratory care.

Dr. Britt moved to have Ms. Plant research the law/rules to see what would need to be changed to make it a requirement for current certification in order to renew. Mr. Porterfield seconded the motion and the vote was unanimous in the affirmative.
