#### Minutes

The Respiratory Care Advisory Committee of the Board of Medical Licensure and Supervision met on May 7, 2024. This special meeting was held consistent with the Oklahoma Open Meeting Act. Mr. Grantz, having noted a quorum, called the meeting to order at 11:30 a.m. Barbara Smith called roll to establish a quorum on the record.

Following review, Ms. Beard moved to approve the minutes of February 6, 2024, as written. Ms. Ayala seconded the motion and the vote was unanimous in the affirmative.

**ASHLEY BAGLEY** did not appear in support of her application for Respiratory Care Practitioner licensure. Ms. Ayala moved to recommend tabling the application pending a personal appearance before the Committee. Ms. Hennessey seconded the motion and the vote was unanimous in the affirmative.

KIMBERLY DORSEY appeared personally in support of her application for Respiratory Care Practitioner licensure. She last practiced in October of 2020 and her license lapsed in November of 2023. She is NBRC certified through June of 2028. She is not currently licensed in any other state. The applicant stated she totally forgot to renew her license due to family issues. She is currently working with PAM Health, Long-Term Acute Care as a tech. She stated that she completed 12 hours of CEUs plus certifications in BLS and ACLS. Following review and discussion, Ms. Beard moved to recommend approving the application pending completion of the

file to include confirmation of earned CEUs. Ms. Ayala seconded the motion and the vote was unanimous in the affirmative.

**TERESA LEE** appeared virtually in support of her application for Respiratory Care Practitioner licensure. Her application was tabled on December 4, 2023, pending a personal appearance. She last practiced in March of 2017 and is currently working in durable medical equipment and is not practicing hands-on respiratory care. The applicant stated she started a transportation business in 2017 and decided last year to return to practice. Her NBRC certification expired in May of 2023. Ms. Beard moved to recommend tabling the application pending her successfully retaking the entry-level examination and a personal appearance before the Committee. Ms. Ayala seconded the motion and the vote was unanimous in the affirmative.

JILL LEWIS appeared virtually in support of her application for Respiratory Care Practitioner licensure. Her application was tabled February 6, 2024, pending a personal appearance. She last practiced in March of 2000. Her NBRC certification does not expire and she is not currently licensed in any other states. The applicant stated that she has trained extensively on respiratory equipment, including with anesthesiologists, in California. She has covered the United States for the last 14 years, traveling and training respiratory therapists on equipment, and licensure was not required for her position with Masimo Durable Medical Equipment in California. Following review and discussion, Ms. Ayala moved to recommend approval of the application pending completion of the file to include successfully retaking the entry-level examination. Ms. Beard seconded the motion and the vote was unanimous in the affirmative.

**JOSEPH NIEKAMP** did not appear in support of his application for Respiratory Care Practitioner licensure. Ms. Ayala moved to recommend tabling the application pending a personal appearance before the Committee. Dr. O'Neal seconded the motion and the vote was unanimous in the affirmative.

Next, the Committee reviewed applications for licensure. Following review and discussion:
