Minutes

The Registered Electrologist Advisory Committee of the Board of Medical Licensure and Supervision held a meeting on October 28, 2024, in accordance with the Open Meeting Act. Advance notice of this regular meeting was transmitted to the Oklahoma Secretary of State on December 1, 2023. The notice and agenda were posted on the Board's website on October 23, 2024, at 2:04 p.m. in accordance with 25 O.S. § 311(A)(9).

Having noted a quorum, Ms. Dooly called the meeting to order at 10:00 a.m. Barbara Smith established that a quorum was present for purposes of the record.

Following committee review, Ms. Dooly moved to approve the minutes of the October 16, 2023, meeting as written. Ms. Winzeler seconded the motion and the vote was unanimous in the affirmative.

Ms. Smith explained that the law only allows for election of a chairperson so the election will be for the role of chair only and will not include a vice-chair. Ms. Noa moved to nominate Ms. Dooly for the role of Committee Chair. Ms. Dooly accepted the nomination. Ms. Noa seconded the motion and the vote was unanimous in the affirmative.

The Committee then reviewed the incomplete application of **SARAH KRISTINE KRAUS** for Registered Electrologist licensure. Following review and discussion, Ms. Winzeler moved to recommend approval of the application pending completion of deficiencies including proctoring and examination. Ms. Noa seconded the motion and the vote was unanimous in the affirmative.

Next, the Committee reviewed Continuing Education Courses as listed on *Attachment #1* to the agenda. Following committee review and discussion:

- Ms. Noa moved to recommend denying **Early Child Online, Reducing the Risk of SIDS/SUID Safe Sleep** las isted on *Attachment #1*. Ms. Winzeler seconded the motion and the vote was unanimous in the affirmative.

- Ms. Winzeler moved to recommend approving **Thermacube LLC, Childcare Training (ELCCT)** as listed on *Attachment #1* for a total of 10 hours only. Ms. Dooly seconded the motion and the vote is recorded below:
