

## Minutes

The Occupational Therapy Advisory Committee of the Board of Medical Licensure and Supervision met on October 8, 2024, in accordance with the Oklahoma Open Meeting Act. Advance notice of this regularly scheduled meeting was transmitted to the Oklahoma Secretary of State on December 1, 2023. The notice and agenda were posted on the Board's website on October 3, 2024, at 9:50 a.m. pursuant to 25 O.S. § 311(A)(9).

Having noted a quorum, Barbara Smith, Executive Secretary, called the meeting to order at 9:01 a.m. and called roll for purposes of the record.

Following Committee review, Ms. Gorman moved to accept the meeting minutes of July 30, 2024, as written. Ms. Wallace seconded the motion and the vote was unanimous in the affirmative.

**JILL BROWN** appeared virtually in support of her application for Occupational Therapy Assistant licensure. Her Oklahoma license expired on October 31, 2005 and she last practiced as an OTA in October of 2020. Her NBCOT certification is current and she is currently licensed in North Carolina. Following review and discussion, Ms. Gorman moved to recommend approval of the application pending completion of the file. Ms. Wallace seconded the motion and the vote was unanimous in the affirmative.

**ELIZABETH GILBERT** did not appear in support of her application for Occupational Therapy Assistant licensure. Ms. Wallace moved to recommend tabling the application pending a personal appearance before the Committee. Ms. Frohling seconded the motion and the vote was unanimous in the affirmative.

**SHERYL McKAY** appeared virtually in support of her application for Occupational Therapy Assistant licensure. Her Oklahoma license expired on October 31, 2021, and she has not practiced since that time. Her application is incomplete and she is not currently licensed to practice in any other state. The applicant stated she has recently obtained 76 CEUs and will be happy to provide those to staff for review. Following review and discussion, Ms. Gorman moved to recommend approval of the application pending completion of the file to include receipt of 72 CEUs. Ms. Wallace seconded the motion and the vote was unanimous in the affirmative.

**STACY ROW** appeared virtually in support of her application for Occupational Therapy Assistant licensure. She last practiced in March of 2023 and she is currently certified through NBCOT. Her application is complete and she is currently licensed in South Carolina. Following review and discussion, Ms. Wallace moved to recommend approval of the application. Ms. Frohling seconded the motion and the vote was unanimous in the affirmative.

**KIMBERLY PITMAN, OT**, appeared virtually in support of her request to supervise more than four OTAs. Committee members discussed the provision for having supervision logs submitted for committee review and whether that was allowed under the current rules. Following review and discussion, Ms. Gorman moved to approve Ms. Pittman's request to supervise a fifth OTA, Amber Alvarado, for up to one year with a record of all consultations (with patient names redacted) provided to licensing staff on a quarterly basis. Ms. Wallace seconded the motion and the vote was unanimous in the affirmative.

Next, the Committee reviewed applications for licensure as shown below:

2. Ms. Gorman moved to recommend approval of the complete application(s) for reinstatement of Occupational Therapy Assistant licensure as listed on *Attachment #1* hereto. Ms. Frohling seconded the motion and the vote was unanimous in the affirmative.
3. Ms. Frohling moved to recommend approval of the complete application(s) for Occupational Therapy Assistant licensure as listed on *Attachment #1* hereto. Ms. Wallace seconded the motion and the vote was unanimous in the affirmative.
4. Ms. Gorman moved to recommend approval of the incomplete application(s) for Occupational Therapy Assistant licensure pending completion of the file(s) as listed on *Attachment #1* hereto. Ms. Wallace seconded the motion and the vote was unanimous in the affirmative.
5. Ms. Frohling moved to recommend approval of the incomplete application(s) for reinstatement of Occupational Therapist licensure pending completion of the file(s) as listed on *Attachment #1* hereto. Ms. Gorman seconded the motion and the vote was unanimous in the affirmative.
6. Ms. Wallace moved to recommend approval of the complete application(s) for Occupational Therapist licensure as listed on *Attachment #1* hereto. Ms. Gorman seconded the motion and the vote was unanimous in the affirmative.

The agenda was reordered at the request of Sandra Harrison. Lisa Cullen asked the committee members to review the current administrative rules and provide suggested amendments to her via email.

Then, Lisa Cullen presented continuing education courses. Following review and discussion, Ms. Wallace moved to recommend approval of the CEU courses listed on *Attachment #2* hereto which have been recommended for approval by the reviewers. Ms. Gorman seconded the motion and the vote was unanimous in the affirmative.

Under “New Business,” Barbara Smith advised that the Committee might also want to review the administrative rules regarding providing supervision logs for OTs wishing to supervise more than four OTAs since that was mentioned earlier in the meeting.

There being no further business, Ms. Gorman moved to adjourn the meeting. Ms. Wallace seconded the motion and the vote was unanimous in the affirmative. The time was 10:12 a.m.
